SUMMARY AND HIGHLIGHTS

Dr. Valaskakis has pursued four converging career paths. He has been an academic, an executive, a consultant and a diplomat. Holding a Ph.D. in Economics from Cornell University and a French law degree, his **academic** career has encompassed 30 years of teaching at the University of Montreal and other universities in Canada and in Europe. As an **executive**, he has headed the GAMMA INSTITUTE, an international think tank, specialized in forecasting and planning studies and has directed major research projects for the Canadian federal and provincial governments and for various international organizations. His **consulting** experience involved being the Chairman of ISOGROUP CONSULTANTS an international strategy and preparing strategic plans for major multinational firms. Finally his **diplomatic** experience has centered on his position as Canadian ambassador to the OECD and the spin-off activities it has generated internationally, including his more activities in promoting the Club of Athens.

- President of the Club of Athens – Global Governance Group, an international initiative involving world leaders from the public and private sectors seeking to establish a pre-negotiating forum for the reform of intergovernmental institutions.

Valaskakis has over the years developed expertise in five areas: global governance, international development, Canadian federalism, technology strategy, forecasting and planning methodologies as applied to business and government. He has sat on a number of boards of directors including the National Bank of Greece Canada, the North American Society of Corporate Planning, and Futuribles International Paris etc.

Dr. Valaskakis has published 8 books, over 100 scientific papers and 20 book length monographs. He has been active on the international lecture circuit and has given about 500 public speeches in the last ten years. About a third of these were major keynote or closing addresses. He has acquired expertise and made contributions in a number of areas, and has received a number of awards and which are described in section 3 below.

Appointed by the Governor-in-Council in 1995, Dr. Valaskakis has represented Canada on the OECD Council the supreme body of the Organization. As Head of Mission of the Canadian Delegation to the OECD he co-coordinated the work of 16 staff members, including 8 diplomats. His duties included overseeing the management of the OECD together with the 28 other ambassadors to which the Secretary-General reports, negotiating conventions and resolutions on behalf of Canada. He was :

He became an assistant professor in June of 1967, an associate professor in 1973 and a professeur-titulaire in 1978. Courses he has taught include micro and macro theory, economic history, international trade and development and forecasting and planning.

Dr. Kimon Valaskakis was President and founder of the Gamma Institute a Montreal-based international think-tank which was described by the Paris newspaper as “un centre de notoriété internationale en Prospective”. Specializing in long-term forecasting studies, the Gamma Institute was born in 1974 as an interuniversity research group of the University of Montreal and Mc.Gill University. In 1989 Concordia University and Ryerson Polytechnic joined GAMMA. In 1984, Gamma became an independent institute and opened a subsidiary in France. It was the subject of a major chapter in Annie Battle’s book *Les Travailleurs du Futur* and of a special issue of *Poland 2000*, the journal of the Polish Academy of Sciences.(see Publications section)

RECOGNITION AND AWARDS

Dr. Valaskakis has received an academic prize from the Max Bell Foundation in 1987 for an article on the role of Government entitled ‘*Should the Gorging Leviathan become Anorexic*’

He was invited over the years to deliver distinguished lecture series including the Conférence Auguste Frigon at the Ecole Polytechnique, the Dunning Trust Lecture at Queen’s University, the Carson Series Lecture at the University of Ottawa and the Prospective lecture at the Conservatoire Nationale des Arts et Metiers in Paris.

In 1997, Professor Valaskakis received the Univerity of Montreal gold medal award for distinguished career service to the University.

Dr. Valaskakis has also been the subject of a number of articles in various periodicals. Five indicators of recognition of work done include:

- (1) A 1982 special issue of the Polish journal *Polska 2000*, a journal of the Polish Academy of Sciences, which was entirely devoted to the work in the future studies field of K. Valaskakis at the Gamma Institute.
- (2) A 1983 article in the Paris newspaper, *Le Monde* describing Gamma as a leading international think-tank in the field of future studies and forecasting.
- (3) Chapter II of the book by Annie Battle, *Les Travailleurs du Futur*, (Paris: Seguers 1986) which focuses on Gamma’s contributions as a major international think-tank. The book is a comparison of leading world think-tanks and places Gamma in the company of the RAND Corporation, Stanford Research Institute, and the Club of Rome etc.

- (4) A report in the British learned journal *Futures* in 1991 describing Valaskakis as one of the 40 leading world futurists.
